- The library went out to bid for renovation/expansion 8 bids received
- Bid Tabulation sheet provided
- RoMAAS, Inc. out of Glen Ellyn was lowest bid at \$2,690,900 highest bid at \$3.581 million
- Alternate bid sheet provided
- Overall Project Budget sheet provided with an estimated total project cost of \$3,729,503
 - Contingency raised from 7% to 10% pending further review
 - o Furniture contingency at 5% furniture cost will be locked down in a few months
 - o Director Kozel-La Ha requesting Village permit fees to be waived
 - o Alternate 2 & 3 not recommended
 - o Alternate 4 in the process of requesting a variance from the Village
 - RoMAAS, Inc. agreed to hold pricing on Alternate 4 for 60 days starting April 15
 - o Alternate 1 HVAC Admin area
 - Engineers/HVAC engineers to look for a more cost-effective plan
 - RoMAAS, Inc. will hold material cost for 30 days, labor cost for 60 days
- Dan recommends denying the Native Grass Regulatory Request due to its financial burden. We have already respectfully declined to the Village.
- Dan proposed to accept RoMAAS, Inc. bid and decline the alternates with consideration that Alternate 1 & 4 are a possibility.
 - o Dan has no prior experience with RoMAAS, Inc.
 - o RoMAAS, Inc. has library construction experience
 - All positive reviews/references
- With your approval, Nanette can accept the Bid on your behalf
